I. Apparently the first major philosopher to identify and write extensively about the issue of intergenerational fairness was John Rawls, *A Theory of Justice*, Harvard University Press, 1971 (See also his *Justice as Fairness: A Restatement*. Harvard University Press, 2001)

IV. Court Case:

To my knowledge, only one judiciary has acted affirmatively on behalf of future generations. In the case, *Oposa vs. Factoran, Jr.*, (1993) the Philippine Supreme Court ruled that representatives of future generations have standing and thus can bring legal action to prevent environmental destruction which diminishes the quality of life of future generations.
