What content would be taught/covered/treated?

- Reintegration into society and personal futures for teen women in conflict with the law through Forward Theater and holistic prospective techniques.

Who would be the students (how many, what demographic and educational categories)?

- Teen women in conflict with the law who belong to the Centro de Diagnóstico y Tratamiento para Mujeres (CDTM) en el Distrito Federal (DF)
- Number could be require by authorities
- Interviews, life stories.

How many hours/days of live teaching/exchange/workshopping would the activity entail?

- Four months. Approximately: february to june, 2015

What online educational activities are foreseen as part of the activity?

- Online spreading of the methodologies, videos about, theatrical exercises theatre presentations

What partners will be implicated in the activity ? (E.g. who provides classrooms)

- Infrastructure of the Centro de Diagnóstico y Tratamiento para Mujeres (CDTM) en el Distrito Federal (DF) Gardens, classroom
- Classroom for corporal exercises and for theatre presentation.
- Review documentation(files) of the teen women participants.

What are the benefits for the Institution and for participants?
